### 3 Types of DD Waivers:

BI = Building Independence

FIS = Family & Individual Supports

CL = Community Living

### Description of Waiver Services

<b>Employment and Day Options</b>	<b>BI</b>	<b>FIS</b>	<b>CL</b>	
Individual Supported Employment	✓	✓	✓	A job coach providing training and support to one individual in an integrated employment or self-employment situation in a competitive job that meets personal and career goals.
Group Supported Employment	✓	✓	✓	Continuous employment related support to groups of 2-8 individuals with disabilities in a competitive job where persons without disabilities are employed.
Workplace Assistance (WA)		✓	✓	Services are provided to someone who has completed job development or nearly completed job placement training but requires more than typical job coach services to maintain employment. WA. services are supplemental to job coach services.
Community Engagement (CE)	✓	✓	✓	Services are provided in groups of no more than 1 staff to 3 individuals. C.E. fosters the ability of the individual to acquire, retain, or improve skills necessary to build positive social behavior, interpersonal competence, greater independence, employability & personal choice necessary to access typical activities in community life such as those chosen by the general population. May include community educ., training, vol. and retirement activities.
Community Coaching	✓	✓	✓	For individuals who need 1:1 support to build a specific skill or set of skills to address a particular barrier(s) preventing a person from participating in activities of Community Engagement.
Group Day Services	✓	✓	✓	Provided in groups of no more than 1 staff to 7 individuals. Opportunities for peer interactions, community integration, career planning & enhancement of social networks. Supports may also be provided to ensure individual's health & safety.
Community Guide (General and Housing) <i>New in 2018</i>	✓	✓	✓	Direct assistance and information for an individual to promote inclusion and community participation and for movement to independent housing.
Peer Mentor Supports - <i>NEW in 2018</i>	✓	✓	✓	Peer to peer matches for individuals to discuss specific desired outcomes and interests for greater independence with the mentor suggesting strategies to reach desired outcomes particularly related to living more independently, employment and social opportunities
<b>Self/Consumer-Directed Options (*can also be agency-directed)</b>				
Consumer-Directed Services Facilitation		✓	✓	Services Facilitation assists the individual or the individual's family/caregiver, or Employer of Record (EOR), as appropriate, in arranging for, directing, and managing services provided through the consumer-directed model of service delivery.
Consumer Directed Personal Assistance Services*		✓	✓	Personal assistance services include support with activities of daily living, instrumental activities of daily living, community access, monitoring of self-administered medications or other medical needs, monitoring of health status & physical condition, & work-related personal assistance.
Consumer-Directed Respite*		✓	✓	Services are specifically designed to provide temporary, substitute care for that which is normally provided by the family/other unpaid, primary caregiver of an individual. Services are provided on a short-term basis because of the emergency absence or need for routine or periodic relief of the primary caregiver.
Consumer-Directed Companion*		✓	✓	Nonmedical care, socialization, or support to adults, ages 18 and older. Provided in an individual's home or at various locations in the community.

	BI	FIS	CL	Description of Waiver Services
<b>Residential Options</b>				
Independent Living Supports	✓			Independent Living Supports are provided to adults (18+) that offers skill building & support to secure a self-sustaining, independent living situation in the community and/or may provide the support necessary to maintain those skills.
Shared Living	✓	✓	✓	Shared Living is Medicaid payment for a portion of the total cost of rent, food, and utilities that can be reasonably attributed to a person who has no legal responsibility to support the individual and resides in the same household as the individual. Parents and spouses are excluded.
Supported Living		✓	✓	Supported Living takes place in an apartment/house setting operated by a DBHDS licensed provider & provides 'round the clock availability of staff services by paid staff who have the ability to respond in a timely manner. Supports enable an individual to acquire, retain, or improve skills to live successfully in their home and community.
In-home Support Services		✓	✓	In-Home Support services take place in the individual's home, family home, or community settings & typically supplement the primary care provided by the individual, family or other unpaid caregiver. Services are designed to ensure the health, safety and welfare of the individual.
Sponsored Residential			✓	Sponsored Residential Services take place in a licensed or DBHDS authorized sponsored residential home with no more than 2 individuals supported. Supports enable an individual to acquire, retain, or improve the self-help, socialization & adaptive skills necessary to live successfully in their home & community.
Group Home			✓	Services provided across 24 hours primarily in a licensed or approved home that enables an individual to acquire, retain, or improve the self-help, socialization & adaptive skills to live successfully in their home & community.
<b>Crisis Support Options</b>				
Community-Based Crisis Supports	✓	✓	✓	Community-based crisis supports are supports to individuals who may have a history of multiple psychiatric hospitalizations; frequent medication changes; enhanced staffing required due to mental health or behavioral concerns; and/or frequent setting changes. Supports are provided in the individual's home and community setting. Crisis staff work directly with and assist the individual and their current support provider or family. These services provide temporary intensive supports that avert emergency psychiatric hospitalization or institutional placement or prevent other out-of-home placement.
Center-based Crisis Supports	✓	✓	✓	Supports provide long term crisis prevention & stabilization in a residential setting (Crisis Therapeutic Home) through utilization of assessments, close monitoring, & a therapeutic milieu. Planned & emergency admissions. Planned admissions provided to individuals who are receiving ongoing crisis services & need temporary, therapeutic interventions outside of their home setting in order to maintain stability. Crisis stabilization admissions provided to individuals who are experiencing an identified behavioral health need and/or a behavioral challenge that is preventing them from experiencing stability at home.
Crisis Support Services	✓	✓	✓	Services provide intensive supports by appropriately trained staff in the area of crisis prevention, crisis intervention, and crisis stabilization to an individual who may experience an episodic behavioral or psychiatric crisis in the community which has the potential to jeopardize their living situation. This service is designed to stabilize the individual & strengthen their home so the individual can be supported in the community during & beyond the crisis period.

	BI	FIS	CL	<b>Description of Waiver Services</b>
<b>Medical and Behavioral Support Options</b>				
Skilled Nursing		✓	✓	Part-time or intermittent care that may be provided concurrently with other services due to the medical nature of the supports provided. Medical services that are ordered by a physician, nurse practitioner or physician assistant & are not otherwise available under the Medicaid State Plan.
Private Duty Nursing		✓	✓	Individual & continuous care (in contrast to part-time or intermittent care) for individuals with a medical condition and/or complex health care need, certified by a physician, nurse practitioner, or physician assistant as medically necessary to enable the individual to live at home, rather than in a hospital, nursing facility or Intermediate Care Facility for Individuals w/ Intellectual Disability (ICF-IID).
Therapeutic Consultation		✓	✓	<p>Services designed to assist the individual and the individual's family/caregiver, as appropriate, with assessments, plan design, and teaching for the purpose of assisting the individual enrolled in the waiver. Provides expertise, training, and technical assistance in any of the following specialty areas to assist family members, caregivers, and other service providers in supporting the individual. The specialty areas are:</p> <p>(i) psychology, (ii) behavioral consultation, (iii) therapeutic recreation, (iv) speech and language pathology, (v) occupational therapy, (vi) physical therapy, and (vii) rehabilitation engineering.</p>
Personal Emergency Response System (PERS)	✓	✓	✓	Service that monitors individual's safety in their homes, & provides access to emergency assistance for medical or environmental emergencies through the provision of a 2-way voice communication system that dials a 24-hour response or monitoring center upon activation & via the individuals' home telephone system. Medication-monitoring services are also available but must be physician ordered & are not a stand-alone service.
<b>Additional Options</b>				
Assistive Technology	✓	✓	✓	Specialized medical equipment, supplies, devices, controls, appliances, not available under the Medicaid State Plan, which enable individuals to increase their abilities to perform activities of daily living, or to perceive, control, or communicate with the environment in which they live, or which are necessary for life support, including the ancillary supplies & equipment necessary to the proper functioning of such technology.
Electronic Home-Based Services	✓	✓	✓	Goods/Services based on Smart Home© technology. Includes purchases of electronic devices, software, services, & supplies not otherwise provided through this waiver or through the Medicaid Stat Plan, that would allow individuals to access technology used in the individual's residence to support greater independence & self-determination.).
Environmental Modifications	✓	✓	✓	Physical adaptations to the individual's primary home, primary vehicle, or work site that are necessary to ensure the health & welfare of the individual, or that enable the individual to function with greater independence.
Individual and Family/Caregiver Training		✓	✓	Training and counseling to individuals, families and caregivers to improve supports or educate the individual to gain a better understanding of his/her disability or increase his/her self-determination/self-advocacy abilities.
Transition Services	✓	✓	✓	Nonrecurring set-up expenses for individuals who are transitioning from an institution or licensed or certified provider-operated living arrangement to a living arrangement in a private residence.
Benefits Planning - <i>New in 2018</i>	✓	✓	✓	Individualized analysis and consultation for those receiving social security benefits to understand benefits and explore employment, start work and effect of work on benefits. 9.23.18
